
MARCH EETING NOTICE

FIFTY YEARS AGO ON THE KINNI

(Orv Johnson recently received a missive in the mail from an old friend from River Falls, and the letter contained a few good yarns about the Kinni in days of yore. Here's a bit of that letter.)

"You sure brought back memories when you said you fish in the Kinni. My dad took more large German brown trout out of there than anyone from 1915 to 1955. The Rod and Gun Club mounted one, and I guess it is still in the state capital with his name on it. I have his fly rod he won in (a fishing contest) in the 1920's.

"About a month before the season opened I would go with him up the river north of River Falls 2 to 6 miles. We would crawl up on the bank on our bellies just upriver from a deep hole where the water was quite shallow. A little before sundown we would watch for the big fish. They would come up from the deep pool to feed in the shallow water. You could only see their dorsal fin above the water, some times you would see just a big "V" wave as a really big one swam up to feed."

WISCONSIN TROUT SEASON IN JEOPARDY

Surely most chapter members are aware of recent news reports suggesting that the Wisconsin DNR is at least considering closing a portion of Wisconsin to trout fishing this year due to low water conditions in many streams. The latest news suggests that streams in the northeast and southwest parts of the state are in the greatest danger of being closed. DNR officials think streams in our region will have sufficient protection from the new regulations so that closing them won't be warranted.
