## DAM NOTES

**WILLOW RIVER:** Representative Shelia Harsdorf's office reported that the state will supply \$4 million of an estimated \$5.4 million needed to replace the Willow Falls Dam. Local sources must come up with the remaining dollars by August to be included in the budget for 1992-93 or the dam will be removed. Kiap-TU-Wish has gone on record opposing the dam.

**KINNICKINNIC RIVER:** River Falls city officials have awarded Ayres Associates of Eau Claire a contract to evaluate the condition of the Powell Dam (lower) at a cost not to exceed \$14,000. City Officials report that problems exist that are very similar to those previously repaired at the Junction Falls dam (upper). Kiap-TU-Wish has voiced our opposition to these dams at numerous City-TU meetings.

**APPLE RIVER:** Northern States Power has proposed changes to their minimum flow requirements at the Apple River hydro facility. The minimum flows will be:

April 1 to Oct. 31	New	Old

## CREATIVE CONTRIBUTIONS

Having a plan to make a donation to a nonprofit organization such as TU can be very rewarding. There are many ways of making a contribution. Donations of time and raffle prizes are the basis for having a successful fund raiser. There are other ways of making gifts as well. Planned deferred giving is a concept that would implement a plan of continued giving long after the donor has died.

1. Gifts of Cash or Cash Equivalents. The most common method of making a gift in cash is to write a check to the chapter. However, the same end result could be achieved by giving stock, rare coins, cash value life insurance annuities and mutual funds. There might even be more possibilities. These types of assets would accomplish income to the Chapter and a tax deductible gift by the donor.

2. Charitable Remainder Unitrust. These gifts are designed to create a "win-win" situation. The potential donor has real estate that spins off good cash flow. The real estate is placed in an Irrevocable Trust. The Trust collects the income from the property. There is a tax credit that is allowed and passed through the donor. This income stream will be paid to the donor for as long as the life lasts. After the death of the donor, the nonprofit organization can then do whatever it wants with the property.

3. Gift of Life Insurance. Let's say that we have a \$5,000 life insurance policy. The dividends are paying the premium and the donor doesn't require the "death benefit" any more. The insured could sign over ownership of the policy to the Chapter. The owner could take a deduction for the gift. Another alternative is to buy a new policy naming the Chapter as the owner and beneficiary with the premiums being deductible.

When considering a gift like those discussed, always contact your accountant or legal council.


